Your House Has a History by Susan Teich, OBPOA Historian

In 1948, North Braeswood westbound from South Main ended at Kelving, a cul de sac. That was the year Harry Pepper moved into his house at 2314 North Braeswood. His neighbors regaled him with stories about how the cul de sac had been a lovers' lane before houses were built and it became less secluded. Old Braeswood children used it as a play area.

Mr. Pepper bought the house, built in 1930, for \$31,500. During his ownership, the air conditioning has progressed from an attic fan to window units to a water tower and, finally, to compressors.

At the end of the cul de sac was Glenn McCarthy's estate—his colonial style house, acreage, and horses. (The tile curb signs for Glen Haven Blvd. use "Glenn" instead of "Glen," because the street was named for him. McCarthy, who was played by James Dean in the movie *Giant*, owned the Shamrock Hilton Hotel.)

Eventually, the City of Houston exercised its right of eminent domain to extend North Braeswood through to Kirby. Later, Harold Farb bought the remaining McCarthy estate and built apartments.

Mr. Pepper can provide such details about Old Braeswood, because, at age 96, he is its oldest and longest residing resident. *(Continued on Page 3)*

Old Braeswood Park Renovation by Christine Robins

Old Braeswood Park Corporation is kicking off 2008 with a fundraising effort for the renovation of Braeswood Park and nearby triangular esplanade. Your help is vital to the success of this endeavor.

Working with the Houston Parks Board, Old Braeswood Park Corporation has commissioned the design of a new play structure to replace the current non-compliant central timber play structure. The total cost for this renovation project is just over \$70,000.

The specific project goals are as follows:

Street Reconstruction Update by Evalyn Krudy

Neighbors have been complaining for years about the condition of our streets and infrastructure. To address these concerns, last summer our block captains went door to door to collect signatures on petitions calling for the replacement of our streets and failing infrastructure with new state of the art concrete roadways, curbs and gutters, storm sewers and sidewalks.

Although quite a few signatures were collected, more are needed to qualify the 20 interior blocks of Old Braeswood for reconstruction. Volunteers are needed to help complete the petition drive to request that the City of Houston rebuild our streets, storm sewers, curbs,



gutters and sidewalks. Interested volunteers should contact either Sally Miller (832-452-0113) or the OBPOA office (713-807-1787), info@oldbraeswood.com.

Most of our streets have the original pavement covered by several layers of asphalt. Curbs and gutters are heaving and collapsing in a number of locations and some sidewalks are cracked and dangerous. Street construction standards have changed since the roadways were first laid and

roads are now much thicker and contain more rebar to prevent settling and cracking.

Although asphalt topping can provide a smooth surface, it is really a temporary solution with a life expectancy of 5 to 7 years and does not address the problem with the original underlying roadbed. Further, adding more asphalt negatively impacts drainage (Continued on Page 5)

Unified Neighborhood Action by Dee Murray

In December, a few Old Braeswood residents initiated a petition to benefit many of our neighbors. The petition was based on Houston's Solid Waste Department informing residents that trash would no longer be picked up on side streets. The new City policy requires residents on corner lots to place their trash bins in front of their houses.

This policy was forcing people on corners with driveways in the rear part of their lots to drag their trash out to the front street. Obviously, this did not make residents along Morningside or Kelving happy. After discussions with OBPOA Board members, Roger and Sharon O'Neil put together a petition requesting reconsideration of the policy. They went door to door, talked to neighbors and collected signatures of 40 residents opposing the policy.

The petitions were then submitted to Council Member Anne Clutterbuck (District C), Harry Hayes (Director of Solid Waste Mgmt.) and Mayor Bill White.

Anne Clutterbuck responded to the letter and is working with Harry Hayes to attempt a resolution.

Dear Old Braeswood POA:

In response to the article in the recent newsletter by Charles T. Bruner regarding mail holds at the post office, I'd like to report that I've had good success, with one exception, using the Postal Service website to arrange mail holds. The service is available at http://www.usps.com/.

By following the links to "Household" and then "Your Mail Delivery," I have been able to enter my home address, mail hold and resume dates, and any detailed notes regarding mail delivery. This has worked very well almost every time.

On one occasion, when we were traveling for several weeks during the summer, our regular mail carrier was also traveling. The mail hold started several days late — and, worse yet, the held mail was delivered several weeks late. This was not a good result, but our mail carrier apologized for the error and noted that it happened when he was not there to take care of the mail hold properly. No mail was permanently lost.

I hope this information is helpful to other residents of Old Braeswood.



Mr. Pepper recalls that Braes Bayou was narrow and unpaved. Sometimes it overflowed. Once, water came to the door of the Peppers' house. A friend came in a boat and took the Pepper children (3 girls) to the Shamrock Hotel and safety.

Mr. Pepper had neighbors whose names are still familiar: Brochstein (makers of office and store fixtures); Battlestein (downtown department store); Gordon (jewelers); Rausch (makers of steel pipe).

Mr. Pepper moved to Texas from Providence, RI, at age 13, and supported himself by selling newspapers in the Old Cotton Exchange Building. After graduating from Sam Houston High School, he went to UT Austin on a football scholarship. Unfortunately, serious injuries to his father in a car accident required that he drop out during his first semester to support the family.

By the time of his marriage to Esther Goldberg in 1938, Mr. Pepper owned a rendering business. During WW II, housewives saved their cooking fat and brought it to the grocery store to exchange for stamps toward the purchase of meat. The fat went into 55-gallon drums which Mr. Pepper took to his rendering plant, and, after reprocessing, pumped the fat into heated tank trucks for sale to Proctor & Gamble in Dallas (for soap) or to auto manu-

facturers (to lubricate motor block castes to prevent bubbles on the surface of the cast metal). He sold the plant in 1957, and thereafter devoted himself to real estate investment and development.

Mr. Pepper has a multitude of awards. Last year, he was the starter for the calf scramble event at the Houston Livestock Show & Rodeo during its tribute to him as its oldest volunteer. In 2003, he was inducted into the National Jewish Sports Hall of Fame. He cycled yearly in the National Special Olympics until he found that he was the only person remaining in his age class.

patterns by raising the grade of the street surface. The City of Houston will asphalt streets once a decade, but this work does not include replacement or repair of curbs, gutters, storm sewers or sidewalks.

The Neighborhood Street Reconstruction Program (NSRP) will replace streets with concrete including curbs, gutters, sidewalks, and storm sewers. The only way to upgrade city streets and infrastructure permanently is through this program. Although the work can be a little disruptive, it adds value to our homes and is funded by tax-payer dollars. Qualifying requests are usually funded within 5 to 7 years. Afton Oaks and Braeswood Place have both gone through this process and the results speak for themselves.

Last summer and fall, our block captains spent countless hours meeting with neighbors to explain the program and collect signatures, but it was often a challenge to find neighbors at home; and, as a result, only a few blocks achieved the required 75% support. We will continue to collect signatures, but more volunteers are needed to help with this effort.

Several owners have expressed concern that signing the petition would obligate them to pay for the improvements out of pocket. However, no one has been assessed by the City since 1991. Assistant City Attorney Don Cheatam says, "the City has not collected assessments for street reconstruction in over a decade and does not plan to do so again." A certain percentage of the City's annual budget is set aside each year for this program and projects are approved on a first come, first serve basis. The City Engineer in charge of this program reports that the wait for reconstruction is growing because of the popularity of the program. 
