Old Braeswood lost one of its early residents, and a delightful and thoughtful neighbor on July 2nd with the death of Beadie (Beatrice) Lewis. She was still living in the house that she and her husband built in 1953 at 2511 Maroneal. And despite her



age of 104 years, she remained active with two book clubs and a Mahjong group. Beadie was interviewed about her life and her house for the April/May 2013 issue of the Old Braeswood newsletter.

Your House Has a History by Susan Froehly Teich, OBPOA Historian



The house at 2305 Blue Bonnet is first listed in the Houston City Directory in 1937, the home Donald Wynn Crosby. He was initially listed with his first wife, Hazel, and then later with his second wife, Mildred (Millie). A maid, Anna Mae Trumb, lived in the rear.

Donald grew up in the oil business. His father was pioneer Texas oilman Allen Wynn Crosby, founder of Wynn Crosby Drilling Company, vice president of Navarro Oil Company, vice president of Texas Iron Works Sales Corporation, and General Superintendent of Sinclair Oil. After his death in 1945, son Donald became president of Wynn Crosby Drilling and founded Don Crosby Drilling Company. Don outlived his father by only four years.

The deaths of the two Crosby men set in motion a series of lawsuits that entertained Houstonians with sensational headlines for several years.

The first lawsuit was filed to contest Don's 1944 will disinheriting his children and leaving his estate to wife Millie. A "lost" will executed in 1949 was alleged. It would have left all but \$10,000 (out of an estate of \$282,109) to the children of Don and his first wife. Millie denied existence of the will and it was never produced. Presiding in that case was County Judge Glenn A. Perry.

Family history soon repeated itself with another will contest after the 1950 death of Don's mother (Wynn Crosby's wid-

ow), Helene. She had remarried, to Frank A. Simmons, but was seeking a divorce from him at the time of her death.

Helene's 1950 will left the bulk of her \$3M to \$4M estate to Baylor College of Medicine for a needy-student fund. The will stated that Frank Simmons had refused to return an earlier will so that she could destroy it. Helene's family obtained an injunction barring Frank from attending her funeral. During probate, a handwritten will from 1949 was produced, leaving Helene's estate to Helene's siblings. Frank contested both wills and produced a 1946 will leaving Helene's estate to him. Adding to the confusion, Don Crosby's first wife filed a 1949 will on behalf of her children. The lawsuit lasted two years and was settled in the court of Judge Clement McClelland with Frank Simmons receiving \$500,00 cash, a \$250,000 house in Pacific Palisades (California), a diamond ring, and three late model Cadillacs. Helene's four siblings and Baylor each received \$1M. The Crosby oil companies were dissolved by court order so that their assets could be distributed. The final distribution to Baylor from Helene's estate was ordered in 1956, and deposited by Baylor in The Crosby Estate Student Loan Fund.

There's more. In 1952, the IRS filed a lien against Frank Simmons for \$437,351, almost the entire amount of his cash from Helene's estate. The IRS accused Frank of underreporting the income of the two Crosby drilling companies in



1945-1947 while he served as an officer of those companies. It also accused him of underreporting income on his joint return with Helene at that time. This claim appears to have been settled.

The fireworks in the Crosby family postdated their residence in Old Braeswood. By 1940 ownership of the Blue Bonnet house had passed to Lillie Marie (Perlitz) and James Pascal Hamblen. Jake was president of Southern Electric Supply Company and Chairman of the Board of Fannin Bank. His philanthropic works are too extensive to enumerate, but during WWII he was a "dollar a year" man for four years as Chairman of the War Production Board Advisory Committee, and he later was fond of noting that "they still owe me four bucks.' Jake's success in raising funds for Roman Catholic charities earned him the title of Knight of St. Gregory, bestowed in 1948 by Pope Pius XII.

Jake died in 1972, but the house stayed in the Hamblen family. Jake and Lillie's daughter Martha Ann had married Vern V. McGrew, Jr., and they became the new owners. Vern was a local

hero. His senior year at Lamar High School (1946), he set the Texas State Record in high jump. Then at Rice University, he won the 1950 NCAA high jump title with a jump of over 6'7". He competed in track and field for the USA at the 1948 Olympics in London, the youngest on the team at age 18. He was the first Olympian from a Houston high school, and the second Olympian from Rice. His career best clearance was 6' 8 1/4 " using the western roll technique. He received a law degree



from the University of Texas and worked for Humble Oil for 30 years.

Neill Parrish Davis and wife Ruth followed in about 2000 as owners of the Blue Bonnet house. Neill was a Trustee of Strake Jesuit College Prep and on the Board of the Alley Theatre. He worked in the clothing industry serving as CFO of Men's Wearhouse, Inc., CEO of Francesca's and as a co-founder of FOUND.

The current owners, Denise J. and Edwin L. Thomas, bought the house from the Neill family in 2012. Like her predecessors Lillie Marie Hamblen and Martha Ann Hamblen McGrew, Denise was active in the Old Braeswood Garden Club. Ed is a materials scientist and mechanical engineer who was a department head at M.I.T. before being recruited by Rice University to serve as Dean of the George R. Brown School of Engineering. Denise and Edwin left Houston for College Station and Texas A&M and their house is now on the market, awaiting its next chapter in Houston history.



Ask Elayne by Elayne Kozounis, OB Gardener

We have had a lot of rain so far this summer, but during most summers, July and August are not only hot, but dry. We may still be in for that kind of weather.

I cannot urge too strongly that all trees planted last season be given plenty of water during hot, dry periods throughout the summer and late into fall. Also, young trees will be much happier during hot, dry months if they are given heavy mulch of straw or leaves.



Maintain close and effective working relationships with A little background about trees: A tree is a woody plant with a single erect stem, growing to a height of 10 feet or more. While shrubs also are woody, they are usually smaller than trees and tend to have many stems growing in a clump. One reason that many of us fail to understand trees is that they live on a different time scale than we do. One of the oldest trees on Earth, a spruce in Sweden, is more than 9,500 years old. That is 115 times longer than the average human lifespan. Creatures with such a luxury of time can afford to take things at a leisurely pace. The electrical impulses that pass through the roots of trees move at the slow rate of 1/3of an inch per minute. Why do trees pass electrical impulses through their tissues at all? The answer is that trees need to communicate, and those impulses are just one of their many means of communication. Trees also use the senses of smell and taste for communication. If a giraffe starts eating from an acacia, the tree releases a chemical into the air that signals other trees that a threat is at hand. The other trees may then release chemicals into their leaves to make the leaves taste bitter.

> Understanding trees is an essential part of our learning to be good stewards of the Earth.

Trash & Recycling Schedule

Recycling Every other Tuesday (B)

Dates July 7 & 20 Sept. 14 & 28

August 3, 17, 31 Oct. 12 & 26

Household Trash Tuesdays (in city provided bins)
Yard Waste Tuesdays (in biodegradable bags)

Junk / Tree Limbs 3rd Monday of each month

Junk Waste (+ tree limbs) in Even months

Tree waste only in Odd months

Place household garbage or recycling at the curb in the city-provided automated bins no earlier than 6 p.m. the evening preceding collection and no later than 7 a.m. on the day of pick up. Remove bins from curb no later than 10 p.m. on collection day. Bins left on the street beyond these times are subject to city fines. Ensure bins are accessible and not blocked by vehicles. Space bins a minimum of 3 feet apart.

Yard waste must be contained in city-approved biodegradable bags and placed at the curb. Branches must be tied into 3-4 ft bundles.
